## BARAN TURSUN FOUNDATION STRATEGIC ACTION PLAN

The Baran Tursun Foundation Strategic Action Plan serves as a **guiding document for preventing human rights violations, redressing grievances, and achieving long-term social transformation**. The plan aims to ensure consistency, impact, and sustainability in all of the foundation's work.

### 1. PURPOSE AND SCOPE

The Baran Tursun Foundation Strategic Action Plan outlines a roadmap for activities aimed at protecting the right to life, encouraging law enforcement to act in accordance with human rights, strengthening access to justice, and supporting freedom, democracy, social peace, and coexistence.

This plan consists of **monitoring and reporting, advocacy, capacity building, legal support, and awareness** components.

### 2. STRATEGIC OBJECTIVES AND AREAS OF ACTION

#### **Strategic Objective 1 : Monitoring and Documenting Violations of the Right to Life**

##### **Actions:**

- Systematic monitoring of death, injury, torture, and ill-treatment cases perpetrated by law enforcement in both indoor and outdoor settings.
- Creating and updating a case-based database.
- Preparation of annual and thematic human rights reports.

**Expected Effect:**

Raising visibility for ill-treatment and violations of the right to life in both indoor and outdoor settings, and strengthening evidence-based advocacy.

**Strategic Objective 2 : Strengthening Access to Justice**

**Actions:**

- Providing legal advice and guidance to victim families.
- Developing cooperation protocols with bar associations and lawyers.
- Strategic litigation Supporting litigation processes

**Expected Impact:**

Combating impunity and strengthening the right to a fair trial.

**Strategic Objective 3 : Development of Human Rights-Based Security Policies**

**Actions:**

- Preparing policy analyses on law enforcement practices.
- Conducting advocacy talks with local and central governments.
- Submitting policy recommendations to national and international mechanisms.

**Expected Impact:**

Widespread adoption of an accountable, transparent, and rights-based security approach.

**Strategic Objective 4: Strengthening the Rights of Children and Young People**

**Actions:**

- Human rights and participation rights training for children and young people.
- Workshops on combating discrimination and hate speech.
- Supporting the active participation of young people in advocacy processes.

**Expected Impact:**

Creating a profile of a rights-conscious, participatory, and peaceful youth.

**Strategic Objective 5: Strengthening Institutional Capacity and Partnerships**

**Actions:**

- Monitoring, reporting, and advocacy training for NGOs.
- Active participation in national and international networks.
- Updating corporate policy and ethics documents.

**Expected Impact:**

A sustainable, strong, and effective civil society structure.

**3. CROSS-CUTTING THEMES**

At all stages of the strategic action plan:

- **Gender equality**
- **Child protection principles**
- **Anti-discrimination**
- **Environmental sustainability**
- **Participation and transparency**

will be taken as the basis.

**4. MONITORING, EVALUATION AND REPORTING**

- Measurable indicators will be defined for each strategic objective.
- Annual activity reports will be prepared.
- Independent evaluation and feedback mechanisms will be implemented.

## **5. BARAN TURSUN FOUNDATION - MISSION**

The Baran Tursun Foundation is an independent civil society organization established to prevent violations of the right to life, strengthen access to justice, and increase accountability in the use of public power. The foundation's core mission can be summarized under the following headings:

### **1. Protection of the Right to Life**

- Preventing law enforcement violence and arbitrary use of force.
- Advocating for law enforcement to act in a lawful, transparent, and accountable manner.

### **2. Support for Victims and Their Families**

- To the families of those who lost their lives or were injured as a result of police violence, unsolved cases, or unlawful use of force:
  - Legal advice
  - Psychosocial support
  - Providing guidance in access to justice processes.

### **3. Monitoring and Reporting Human Rights Violations**

- To document violations of the right to life associated with law enforcement.
- To make violations visible.
- To provide regular reporting to national and international mechanisms.

### **4. Development of Rights-Based Security Policies**

- Supporting internal security reforms based on human rights norms.
- Advocating for strengthening democratic oversight, transparency, and accountability mechanisms.

### **5. Promoting a Culture of Social Peace and Justice**

- Young people, families, and society in general:
  - A sense of justice
  - culture of living together

To conduct training, workshops, and activities aimed at raising awareness of rights.

## 6. BARAN TURSUN FOUNDATION – VISION

**The vision of the Baran Tursun Foundation** is to create a society where everyone's right to life is guaranteed, law enforcement agencies are accountable, transparent, and operate in accordance with human rights; and where justice, equality, and social peace are strengthened.

The foundation's long-term goal is;

- Where violations of the right to life have been eliminated,
- Human rights-based security policies are established in all state institutions,
- Victim families can access justice quickly and effectively,
- Where young people, children and adults are aware of their rights,
- Our vision is to see a country and a world where nonviolent communication and a culture of peace are widespread in all segments of society.
